Vendor booth must be manned and/or occupied from the official start (11:00AM) and close no sooner than 7:00PM. Vendor agrees to remove all materials and leave its space litter-free. Security is not provided for individual booths. No refrigeration is provided by TVIFF.

The use of any sound devices **must** be approved prior to use by TVIFF. Upon approval, Vendor agrees to maintain any sound from such equipment at a conversational level to avoid interference with neighboring Vendors.

This is a rain or shine event and there will be no refunds given due to inclement weather.

TVIFF will not be responsible for losses of any kind, whether by fire, theft, vandalism or acts of nature. Vendor agrees to indemnify, defend, and hold harmless TVIFF and Cinema Entertainment Alliance, its officers, agents, staff and volunteers from any and all liability, claims, damages, or injuries to any person during or after the event.
